

**REVALIDATION AGREEMENT**  
**OF**  
**THE MEMORANDUM OF UNDERSTANDING**

**THE WORLD HEALTH ORGANIZATION (WHO),**  
**THE UNITED NATIONS CHILDREN'S FUND (UNICEF),**  
**AND**  
**THE UNITED NATIONS WORLD FOOD PROGRAMME (WFP)**  
**CONCERNING**  
**THE HOSTING ARRANGEMENT OF THE REACH PARTNERSHIP**

This revalidation agreement of the Hosting Arrangement of the REACH Partnership (the "Agreement") is concluded between The World Food Programme (WFP) and The Food and Agriculture Organization of the United Nations (FAO), The World Health Organization (WHO) and The United Nations Children's Fund (UNICEF).

Collectively hereinafter referred to as the "Parties" and each of them a "Party".

**WHEREAS:**

On 7 December 2011, the Parties entered into the Agreement. According to Clause 7.2 of the Agreement, it expires three years from the date of its effectiveness. The Parties are willing to reconfirm their commitment to all terms and conditions of the Agreement, which expired on 7 December 2014, for a period specified hereunder. The Parties also wish to simultaneously amend the Agreement as specified below.

**NOW THEREFORE**, the Parties have agreed to:

Revalidate the Agreement which shall remain in force from the date of its expiration until 31<sup>st</sup> December 2017.

The Parties also agree to amend the Agreement as follows:

1. The goal of REACH as described in Article 1, should no longer be the reduction in underweight children, but should be the reduction in the number of stunted


children by 40% by 2025 as well as the achievement of other World Health Assembly nutrition goals.

2. REACH takes on the leadership for the UN Network for the Scaling up Nutrition Movement (SUN) aiming to improve coherence of UN approaches, programmes and action in countries signatory to SUN.
3. The names of the contact persons listed under article 10.2 are partially outdated. The names shall be replaced by functional titles as follows:
  - REACH Global Coordinator
  - Director, Nutrition Division , World Food Programme
  - Director, Nutrition Division, Economic and Social Development Department, Food and Agriculture Organization
  - Director Department of Nutrition for Health and Development, World Health Organization
  - Chief Nutrition Associate Director, Programme Division, United Nations Children's Fund

This agreement shall be appended to and be construed as an integral part of the Agreement. Any reference to the Agreement in any other documents shall be construed as including this revalidation agreement. All provisions of the Agreement shall continue to be effective until the date of expiration of this revalidation agreement, unless modified through this agreement or any formal future amendments.




